PROPOSED DEVELOPMENT

NOTICE UNDER THE LOCAL GOVERNMENT PART 8 ARTICLE 81 OF THE PLANNING AND DEVELOPMENT REGULATIONS 2001, (AS AMENDED)

Notice is hereby given that the Council proposes to carry out the following works:

Construction of 15 dwelling units comprising 7 houses (2no. 2-bed, 2 storey semi-detached houses, 4no. 3-bed 2 storey semi-detached houses, 1no. 4-bed 2 storey detached house) and 8 apartments (4no. 1-bed apartments in 1no. 2 storey block, 4no. 2-bed apartments in 1no. 2 storey block), and all associated site works including connection to existing services at Connolly Park, Tobercurry, Co. Sligo.

Sligo County Council has concluded from a preliminary examination, that there is no real likelihood of significant effects on the environment arising from the proposed development and that an Environmental Impact Assessment (EIA) is not required. Any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effects on the environment (i.e. requires an EIA). Demolition of 2 no. bungalow units and construction of 4 no. dwelling units in a 2 storey terrace comprising 2 no. 2-bed houses and 2 no. 1 bed apartments, and all associated site works including connection to existing services at the site of 1 and 2 Old Peoples Homes, Green Road, Coolaney.
